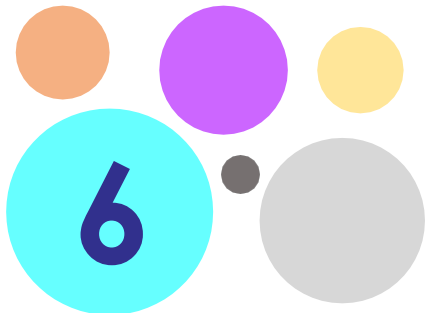
OUR GOALS AND VALUE

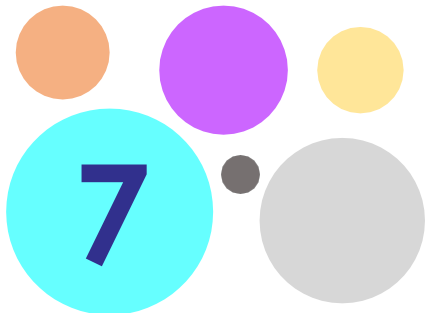

Payment Gateway

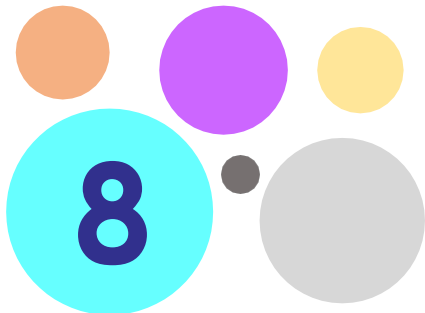

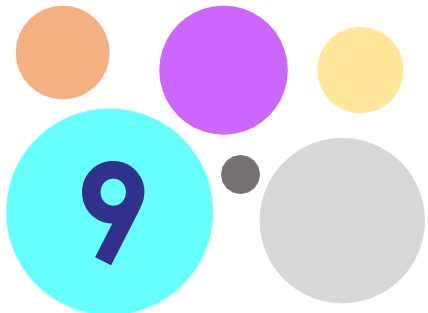

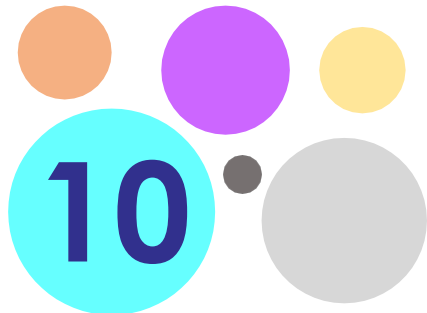
